Delivery of sealed bids must be on or before **August 9, 2023, at 2:00 p.m.**, local time. No allowance will be made for late delivery for any reason.

Bids will be publicly opened on **August 9, 2023, at 2:00 p.m.**, local time, by Chippewa Valley Schools, 19120 Cass Avenue, Clinton Township, MI 48038, evaluated, with awards subsequently to be made by Chippewa Valley Schools.

Bids shall be on forms furnished by Chippewa Valley Schools. A pre-bid conference **will not** be held although bidders are allowed to visit the sites. Site visits must be scheduled at the least disruptive time for the school building. All visitors must check in at the main office upon arrival to any school.

A bidder will be permitted to withdraw his bid, unopened, after it has been submitted if so requested prior to the time specified above for opening of bids. The successful bidder shall be required to enter into a contract with Chippewa Valley Schools. Chippewa Valley Schools is exempt from all taxes. A tax exemption certificate will be issued upon request.

All bidders must provide Iran Linked Business disclosure in compliance with Public Act 517 of 2012 and attach this information to the bid proposal. The bid proposal will be accompanied by a sworn and notarized statement that their business is NOT an Iran Linked Business. The District will not consider a bid proposal that does not include this sworn and notarized disclosure statement.

The right to reject any or all bids, either in whole or in part, or to waive any informalities or irregularities therein, is reserved by Chippewa Valley Schools. The Board of Education will not consider or accept a bid received after the date and time specified for bid.
